General Release – PLEASE READ CAREFULLY

Proper execution for the following release by the undersigned is a prerequisite to the undersigned being able to take part in any and all polo and related riding and lesson activities (“polo activities”) sponsored by or at the Battlefield Park Polo Club LLC, Pageland Lane, Gainesville, VA facility and all related organizations including, but not limited to the United States Polo Association or the Polo Training Foundation.

In consideration of the undersigned participant electing to participate in the Battlefield Park Polo Club LLC participation in polo and riding activities, the undersigned agrees to release, indemnify and hold harmless and on behalf of said participant, his or her heirs, next of kin, dependents, representatives, executors, administrators, successors or assigns hereby does release, indemnify and hold harmless the Battlefield Park Polo Club LLC and all related organizations and their officers, directors, members and employees from any cause of action, claims or demands of any nature whatsoever, which the undersigned, his or her representatives, heirs, next of kin, dependents, executors or administrators, may now have, or have in the future, against the Battlefield Park Polo Club LLC and all related organizations and their officers, directors, members and employees, on account of personal injury, property damage, or accident of any kind, including death, arising out of the participation of said individual in polo activities, including without limitation, participation in or observation of polo/riding/lesson activities.

The undersigned further understands that by signing this Release, he/she covenants and agrees that he/she, as well as his/her heirs, next of kin, dependents, representatives, executors, administrators, successors or assigns, will never institute any suit or action at law or otherwise against the Battlefield Park Polo Club LLC or in any way aid in the institution or prosecution of any claim, demand, action or cause of action for damages, costs, loss of services, expenses or compensation for or on account of any damage, loss or injury either to the participant’s person or property or both, which may result from the participant’s attendance at any participation in polo activities. Participant is hereby given notice of risk inherent in equine activities, including polo activities, including (I) the propensity of an equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an equine’s reaction to sound, movements, objects, persons, of animals; and (iii) hazards of surface and subsurface conditions – and specifically assumes this risk and the risk of acts or omissions that constitute negligence for the safety of the participate by the Battlefield Park Polo Club LLC, whether or not related to the preceding enumerated inherent risks.

The undersigned participant agrees that prior to participating he/she will inspect the facilities and mounts for suitability and safety and related equipment to be used, and if they believe anything is unsafe, they will immediately advise their coach, supervisor or Battlefield Park Polo Club LLC representative of such condition and refuse to participate. The undersigned also agrees at any time the participant can leave the facility at will.

The undersigned participant understands that the Battlefield Park Polo Club LLC did not undertake to provide medical or hospitalization insurance for participants. The undersigned certifies that the participant will be covered by his/her own medical and hospitalization insurance while participating in polo/riding/lesson activities.

Consistent herewith, the undersigned assumes responsibility for the participant's own physical fitness and capability to participate in polo activities and has taken such steps as he/she deems appropriate to assure himself or herself that the participant is fit and capable of such participation. Participant hereby specifically assumes the risk of his/her own negligence in any polo/lesson/riding activities and any negligence of the Battlefield Park Polo Club LLC.

The undersigned further state that he/she is cognizant of all of the inherent dangers of participation in polo activities including the dangers of participating in and observing polo activities; that he/she is legally competent to sign this affirmation and release which he/she had fully read and completely understands; he/she understands the terms herein are contractual and not a mere recital, and that he/she has signed this document as his/her own free act.
